

The Object of the Assembly

From the Constitution of the General Assembly as amended 19 April 2001 and approved by the Charity Commission:

"2.Object

Preamble

We, the constituent congregations, affiliated societies and individual members, uniting in a spirit of mutual sympathy, co-operation, tolerance and respect; and recognising the worth and dignity of all people and their freedom to believe as their consciences dictate; and believing that truth is best served where the mind and conscience are free, acknowledge that the Object of the Assembly is:

Object

To promote a free and inquiring religion through the worship of God and the celebration of life; the service of humanity and respect for all creation; and the upholding of the liberal Christian tradition.

To this end, the Assembly may:

Encourage and unite in fellowship bodies which uphold the religious liberty of their members, unconstrained by the imposition of creeds;

Affirm the liberal religious heritage and learn from the spiritual, cultural and intellectual insights of all humanity;

Act where necessary as the successor to the British and Foreign Unitarian Association and National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, being faithful to the spirit of their work and principles (see appendix to the constitution), providing always that this shall in no way limit the complete doctrinal freedom of the constituent churches and members of the Assembly;

Do all other such lawful things as are incidental to the attainment of the above Object."

In reference to second last clause of Object, the following is a statement of the Objects of the British and Foreign Unitarian Association, as set forth in Rule 2 of its Constitution:

The diffusion and support of the principles of Unitarian Christianity, including the formation and assistance of Congregations which do not require for themselves or their Ministers subscription to any doctrinal articles of belief; the publication and circulation of biblical, theological, scientific and literary knowledge related to Unitarian Christianity; the doing of all such other lawful things as are incidental or conducive to the attainment of the above objects or any of them.

The following is a statement of the Objects of the National Conference of Unitarian, Liberal Christian, Free Christian, Presbyterian and other Non-Subscribing or Kindred Congregations, as set forth in Rule 1 of its Constitution:

To consult, and when considered advisable to take action, on matters affecting the well-being and interests of the Congregations and Societies on the Roll of the Conference, as by directing attention, suggesting plans, organising expressions of opinion, raising funds to carry out the foregoing objects.

The seventy-sixth Annual Meetings of the General Assembly of Unitarian and Free Christian Churches began on Wednesday 14 April 2004 and ended on Saturday 17 April 2004 and were held at University College Chester.

The Opening Business Session began with the parade of banners, and a welcome from the General Assembly President, the Reverend Austin Fitzpatrick. Devotions were conducted by the Reverend David Monk, standing in for the Reverend Brenda Catherall, who was unexpectedly called away from the meetings. Overseas greetings were brought from the Universalist Association of Congregations by Diane Olson and the Reverend Olivia Holmes. Other international visitors were asked to stand and be recognised. Standing Orders for the Conduct of the Annual Business Meetings were adopted and Christine Hayhurst, Roderick Ramage and Dr David Wykes were confirmed as the members of the Steering Committee. Judith Hague delivered the keynote address on the theme "Unitarian address accessibility issues".

At the second business session the Annual Report was presented by the General Secretary and the Council report by the President. The Accounts for the year ended 30 September 2003 were presented by the Honorary Treasurer, Michael Tomlin. The second business session also included a feedback report from the Task Force, established in accordance with Resolution 2 of 2003. Other reports for Commissions, committees and panels were presented at the remaining business sessions by a variety of appropriate spokespersons. Fuller demonstrations of the work of the five new Commissions (Administration: Denominational Support; Education & Training; Ministry; Outreach & Communication) were presented outside of the business meetings during the afternoon and evening slots. The Amy Howarth Rose Bowl was awarded to the Congregation of Blackpool in recognition of their growth of quotapaying membership in 2003/2004 from 4 to 28.

RESOLUTIONS

The following resolutions were carried:

1) FROM THE GA COUNCIL

- That this General Assembly receives the Report of the Task Force with thanks for the hard work and dedication of its members and consultant.
- That this General Assembly endorses the proposal for an Executive Committee to be elected and the proposal that the election be by postal ballot.

- 3. That this General Assembly instructs Council to prepare such motions and constitutional amendments as required to implement the Task Force Proposal for an elected Executive Committee and submit these to the Annual Meetings in 2005 for acceptance or rejection under the ordinary rules and voting majorities that apply under the Constitution and By-Laws of the General Assembly.
- 4. That this General Assembly extends the life of the Task Force until June of 2004 to enable it to undertake further consultation and to evaluate and to prepare proposals for the implementation of the recommendation in the Report regarding the enhancement of leadership positions for consideration at the Annual Meetings in 2005.

2) FROM MORE THAN TWELVE MEMBERS

That this General Assembly of Unitarian and Free Christian Churches congratulates the Unitarian College on its 150th anniversary and gives thanks for all that its staff and students have given to the Unitarian movement over the years.

The Assembly also encourages the Unitarian movement in its support and care of the College in the years ahead.

Further, the Assembly commends to all Unitarians the commemoration volume "Unitarian to the Core" edited by Dr Leonard Smith.

3) FROM THE UNITARIAN PEACE FELLOWSHIP

That this General Assembly of Unitarian and Free Christian Churches supports the proposed establishment of a Government Ministry for Peace.

4) FROM TWELVE MEMBERS

That this General Assembly of Unitarian and Free Christian Churches is seriously concerned about the methods used by the organisation known as Samaritan's Purse to promote its form of Christianity. Its use of the Christmas Shoebox Appeal, under the name of Operation Christmas Child, according to its own literature, website and video, is simply a means of evangelising vulnerable children. This General Assembly alerts its associated congregations and bodies to the methods of this organisation and calls upon Samaritan's Purse in this country to be more open about its aims.

5) FROM GOLDERS GREEN UNITARIANS

That this General Assembly of Unitarian and Free Christian Churches expresses its cordial support for the work of Rabbis for Human Rights and other justice and peace groups in Israel who, inspired by essential Jewish spiritual and ethical values, are seeking justice for the Palestinian people and a peaceful solution to the Israeli-Palestinian conflict. In a spirit of solidarity with all those struggling for peace and reconciliation we send our warm greetings to the people of Neve Shalom-Wahat al-Salam ("Oasis of Peace") and hope that their example may inspire others throughout the Middle East and across the globe.

PROCEDURAL MOTIONS

- That Dawn Buckle be appointed President of the General Assembly of Unitarian and Free Christian Churches for the year 2004-2005
- That this seventy-fifth General Assembly of Unitarian and Free Christian Churches expresses its gratitude for the services provided by the Reverend Austin Fitzpatrick as President during the year 2003-2004.
- 3) That the Reverend Brian Cockroft be appointed as Vice-President for the year 2004-2005.
- That the thanks of the Assembly be given to Michael J Tomlin for his services as Honorary Treasurer, to district association and local treasurers and collectors for their help.
- 5) That Michael J Tomlin be appointed Honorary Treasurer for the year 2004-2005.
- That Messrs Edmund Gibbs & Co be reappointed as Auditors.
- That the Report of the General Assembly Council and the Accounts of the General Assembly be received and adopted.
- 8) That greetings be sent to kindred churches and societies abroad.
- 9) That the thanks of the Assembly be given to the Unitarian College Manchester students for conducting the Anniversary Service, to the Reverend Ann Peart for preaching the Assembly Sermon.
- That the thanks of the Assembly be given to Alan Myerscough, organist for the Anniversary Service, the choir Roundelay and to local Unitarians who arranged other music for the Meetings.
- That the thanks of the Assembly be given to all the local Unitarians, especially from the sponsoring bodies, the East Cheshire Union, the Manchester District Association and the Provincial Assembly, for their inestimable help in organising the Meetings.

STIPEND SCALES

The Assembly approved formally the adoption of the minimum Stipend Scales for Ministers and Lay Pastors for 2004-2005 as recommended by the General Assembly's Stipend Review Committee.

1. Meetings

Council met three times during the year at Unitarian Headquarters, Essex Hall.

2. President

The Dawn Buckle became President at the Annual Meetings at the University College of Chester on 17 April 2004.

3. Nominations

The Council is pleased to nominate the Rev Brian Cockroft as President for 2005/2006, David Dawson as Vice-President and Martin West as Honorary Treasurer. Council has created a motion to abolish the post of Deputy Honorary Treasurer.

4. GA Resolutions

The Council, its departmental Commissions, panels and officers have dealt appropriately with the resolutions passed at the GA Annual Meetings. Where appropriate, letters were sent to government bodies and others.

By far the most significant resolution concerned the Task Force report on governance and leadership. The Task Force final report was ready for the July Council meeting, where it was debated at considerable length.

Council ratified a decision of the Administration Commission to form a Constitutional Working Party consisting of the President, General Secretary, the Rev Steve Dick and the Rev John Clifford. This working party's brief was to consider and draft the constitutional changes that would be necessary to put the Task Force recommendations into force, should they be accepted by future GA annual or extraordinary meetings. The working party also gave detailed attention to the process of consultation and the sequence of events that will be required to progress the consideration of the issues (See the time line on page 12).

Council directed that the Task Force final report should be circulated to the full distribution list, including Associate Members. This was done together with a covering letter from the President. Council also authorised the Administration Commission to take the process forward before its November meeting. As a result, the **Denominational Consultation**Group was formed. This comprised of volunteers from the Task Force (by then

disbanded), Marion Baker, Tony Cann, the Rev Michael Dadson, Jeff Davies, Dorothy Hewerdine and the Rev David Usher and was led by the professional consultant, Colin Fisher. This group proceeded with great energy to arrange regional consultation meetings in Birmingham, Bristol, Cambridge, Edinburgh, London, Manchester and Swansea.

In November 2004 Council consented to the wording of a motion to create the elected Executive Committee, as instructed by the 2004 Annual Meetings resolution and as recommended by the Task Force.

5. GA Theme

The activity to progress the reform of governance and leadership has taken the place of a theme for 2004-2005.

6. Monitoring the Commissions and Panels
Each of the Commissions circulated its full
minutes to Council members, thus providing a
high degree of transparency. Policy decisions
requiring Council approval were listed, either
within the reports or on the agenda, thus
enabling adequate opportunities for critical
examination of the criteria. Panel reports were
grouped in relationship to the appropriate
Commissions. The consent agenda system
enabled attention to be focused on policies,
rather than minute details.

7. Unitarian Future Vision

The responsibility for initiating future planning lies with the Administration Commission. The Administration Commission has commenced a systematic examination of the GA's planning needs and will report progress to Council during 2005.

8. General

District associations, affiliated societies, panels and committees provided detailed reports of their work.

This was founded as a result of a resolution, passed at the GA Annual Meetings 2003, which stated:

"That this General Assembly of Unitarian and Free Christian Churches instructs GA Council to appoint a task force to develop proposals to change the system of governance to have a nationally elected leadership, and to present them at the 2004 General Assembly."

Council appointed a professional consultant, Colin Fisher, and twelve Unitarian volunteers in July 2003, following the recommendation of an independent selection panel. Care was taken to achieve a balance of interests in the selection.

The volunteers were: Marion Baker, Dawn Buckle, Tony Cann, Rev John Clifford, Rev Michael Dadson, Jeffrey Davies, Rev Steve Dick, Dorothy Hewerdine, John Lawrence, Andrew Phillips, Louise Rogers and Rev David Usher.

Numerous meetings were held and an email network carried a vast amount of traffic. A questionnaire was drawn up and circulated to every possible individual within our membership. Over two thousand replies were received and these proved to be of high value in defining the recommendations to be included in the final report.

The final report was not complete at the GA Annual Meetings 2004. However, interim information was available and the following resolution provided a mandate for the Task Force's remaining work:

- "1. That this General Assembly receives the Report of the Task Force with thanks for the hard work and dedication of its members and consultant.
- 2. That this General Assembly endorses the proposal for an Executive Committee to be elected and the proposal that the election be by postal ballot.
- 3. That this General Assembly instructs Council to prepare such motions and constitutional amendments as required to implement the Task Force Proposal for an elected Executive Committee and submit these to the Annual Meetings in 2005 for acceptance or rejection under the ordinary rules and voting majorities that apply under the Constitution and By-Laws of the General Assembly.

4. That this General Assembly extends the life of the Task Force until June of 2004 to enable it to undertake further consultation and to evaluate and to prepare proposals for the implementation of the recommendation in the Report regarding the enhancement of leadership positions for consideration at the Annual Meetings in 2005."

The Task Force completed its role on schedule in June 2004. The final report was circulated to the GA membership in July 2004 and Council has met requirement 3 by issuing Motion 1 to the 2005 Annual Motion 1 to the Annual Motion 2 to the Motion 2 to

As noted in the Council report, several ex-task Force members volunteered to join the Denominational Consultation Group. This Group has held regional seminars to brief Unitarians about the report's recommendations and to hear feedback. This process will include an information presence at the GA Annual Meetings 2005.

Assuming that the 2005 Annual Meeting votes to create the elected Executive Committee, further decisions have to be addressed, most notably about the specification of the next generation of executive leader and the future of Council. These will be debated at the 2005 Annual Meetings and it is envisaged that an Extra-Ordinary General Meeting will be convened towards the end of 2005.

The work of the Task Force and the Denominational Consultation Group was funded by the Bowland Charitable Trust.

The General Assembly thanks the Bowland Trust, Colin Fisher and the Task Force volunteers for their contributions to this major reform of our governance and leadership.

ADMINISTRATION COMMISSION

The Administration Commission replaced the Executive, Finance & Administration and General Purpose committees when established in 2003. Its mission statement is:

To provide the General Assembly of Unitarian and Free Christian Churches with effective administration and to foster trust through good communication.

During 2004, the Commission met in January, May, July and October. The October meeting was residential and held at Luther King House. Any matters requiring prompt decision were progressed by email networking.

Task Force Report: Two Commission members, Dawn Buckle and the Rev Steve Dick, served on the Task Force and were therefore able to facilitate exchanges of information. Dawn ceased her Task Force role when she became GA President in April 2004.

When the Task Force published its final report, Council requested the Commission to undertake the key steps to progress the matter in accordance with the GA resolution of April 2004. Firstly, the report was widely circulated to the membership. The Constitutional Working Party was established to draft proposed changes and establish correct procedures for debate and the sequence of events. Then the Denominational Consultation Group was created to hold regional meetings to inform and gather feedback. (For further details see Council report.)

Unitarian Future Vision: The Commission's first residential meeting, held in October 2003, had identified the following developmental needs for the General Assembly:

a) Clarifying and communicating our relationship with other Commissions: This led to meetings of the Commission chairpersons which have served a most useful purpose.

- b) Building trust: The Commission members were aware of the need to address the questions and queries arising from the TRWP reforms and the Task Force proposals. Each member undertook to contribute towards the clarification of issues, within Council and as they attended diverse denominational events.
- c) GA Finances: The downturn in the Assembly's capital wealth during the period 1999-2003 was a combination of market forces, investment advice, government policies and deficit budgeting. Budgetary control became imperative. Throughout the year the Commission monitored the income and expenditure and made recommendations to Council concerning the 2004-2005 budget.

During 2003, following the sale of the Henderson Charity Investment Division to Newton, the Unitarian Joint Investment Panel made fundamental changes to the denomination's investment structure. Equity shareholdings in individual companies were sold and re-invested in collective investments and some fixed-interest stocks. These decisions have served well. The budgeted investment income has been achieved and, in a climate of improving market conditions, above-average capital appreciation has taken place.

The Commission has paid attention to the need to improve live income. It has therefore given encouragement to the Funding Development Panel and the Associate Membership team. The problem of the downturn of income from the Essex Hall Trust (due to the expiry of its main leases) was partly alleviated by the successful negotiation of a grant from the Bowland Trust for 2004-2005. The GA also received £35K in legacies, one of which is reputed to be the result of our legacy leaflet.

Expenditure remained within budget, because of the staff downsizing of 2003 and the restraint practiced by our Commissions and Panels.

The Commission, being aware that our Honorary Treasurer, Michael Tomlin, was approaching the end of his seven year term of office, were active in the search of his successor. The post was advertised in the denominational press at the end of the year.

The Commission is responsible for the progress of the Chalice Appeal and the Unitarian Millennium Fund. The Chalice Appeal will assist in the funding of the Youth Officer. A small grant was authorised to the Manchester College Old Students' Association (MOSA), to arrange for a speaker. A UMF grant was authorised to fund a residential meeting of district representatives. The existing UMF grant of £20K towards the Youth Officer appointment was increased to £30K.

d) Reorganising the Annual Meetings: The 2003 Review Group had explored ways of simplifying and shortening the Annual Meetings in order to make them more accessible to low income attendees. Following consultation with the Annual Meetings participants, it became obvious that shortened meetings were not acceptable. University College Chester was booked again for 2005 and 2006 because it offered by far the most suitable package for the meetings. The Commission has concluded that the GA now needs an Annual Meetings Panel to plan further ahead.

e) Facilitating the use of Forward Planning in Council: The Commission aspires to provide a lead to Council in orientating it toward longer-term consideration of issues. The members recognise that they have to develop greater expertise in planning matters and have given agenda time to this. However, the Task Force process has inhibited these activities, mostly because of its intrusion on meeting time. The Commission will continue to develop its planning activities in 2005.

Unitarian Headquarters: At each meeting the General Secretary reported on the operation of the Headquarters. The office accommodation was moved within Essex Hall during April 2004 to enable the first floor to be developed for letting purposes.

Laura Wilson joined the staff in January 2004 to perform a wide range of administrative duties. Peter Bixby left in May 2004 and was not directly replaced. Freelance accountant Karen Mallik was engaged to oversee the financial function. John Crosskey has taken over most of Peter's work and has trained Laura Wilson to undertake several of his book-keeping functions. John has revised the IT strategy and the Commission authorised a package of new equipment for delivery in 2005.

The three executive officers, Andrew Mason, Matthew Smith and Ingrid Tavkar, each performed a wide range of duties, described as portfolios, to the best of their abilities. At the end of the year Matthew left, after fourteen years service, to take up employment in local government. The Commission made arrangements to recruit his replacement. The General Secretary's contract was extended by two years and two months and will now expire in April 2007.

After three years of fund-raising, the recruitment of the denominational Youth Officer was authorised. Andrew Green was selected and commenced employment in January 2005.

International: The Commission monitored our links with the International Council of Unitarians and Universalists (ICUU), the International Association for Religious Freedom (IARF) and with Unitarian and Universalist colleagues overseas. The Rev John Clifford represented the GA at the UUA General Assembly in June 2004, which he was attending in a personal capacity. Budgetary restrictions prevented other overseas travel. Christine Hayhurst served on the ICUU Executive Committee. Meadrow Unitarian Chapel, Godalming, played host to the ICUU EC when it met for its annual meeting at a nearby conference centre. Barbara Smith of Trowbridge Unitarians undertook a valuable mission to the Unitarian Union of North East India to assess their primary education work. The Commission decided to contribute towards her return in 2005.

Other work: The Commission drafted a revised system for recommending the nomination of the Vice President-elect and this was approved by Council. Child protection policy issues were considered and recommendations made to Council.

FUNDING DEVELOPMENT PANEL

The panel has met four times during the year.

We commissioned Marketwise Strategies, to produce a feasibility study on the introduction of a trading policy for the movement. This was passed to the Administration Commission for progressing at an estimated potential maximum cost of £7,000. The initiative coincided with an alternative external funding offer and future action was therefore postponed pending acceptance of that offer by the Annual Meetings.

The Chalice Appeal has continued with the collection at the Anniversary Service and a

further appeal on General Assembly Sunday. Although the Chalice Appeal was intended to operate for a three year period, it was agreed to continue with this for a further year but to modify its format dependant on the overall GA funding strategy in 2005. The collection for the 2005 Anniversary Service will go to this Appeal.

The panel is concerned that there is a lack of reliable data concerning funding potential within and outside our movement and is committed to a detailed investigation.

During 2005, the overall funding requirements and likely income streams will become more apparent and we will support the relevant GA officers in developing a viable strategy for the medium term future.

Copies of our outline policy document will be available at the panel's presentation at the Annual Meetings on Wednesday evening 06 April.

DENOMINATIONAL SUPPORT COMMISSION

The Commission, which was first formed in October 2003, met on 6 – 7 February, 18 June and 11 October during 2004. The residential meeting was held at the Bishop Mascall Centre, Ludlow. The Rev Celia Midgley was elected as Chairperson and, mindful of its terms of reference, the members created a mission statement and opening objectives. These were communicated to the movement at the GA Annual Meetings in April 2004.

The most pressing issue was the recruitment of the Denominational Youth Officer. Lis Dyson-Jones, Jeffrey Teagle and the Rev Bob Wightman represented the Commission and, together with Youth Panel members Richard Whitham and Freda Laverick, they formed the recruitment panel. The outcome of their harmonious work was the appointment of Andrew Green, an experienced and well-qualified youth worker in time to commence on 01 January 2005.

The Commission has followed the work of the congregational Consultancy Panel with close interest. The consultancy is drawing to the close of its brief and the commission is actively considering how best to follow through with its valuable analytical services. It was very supportive of the plan to train new consultants for a future voluntary network.

The Commission encouraged the network of the Engagement Support Group. The success of engagement groups is due to the dedication of the facilitators who meet periodically to share their experiences and reinforce their commitment.

The Commission Chair, Celia Midgley, is a member of the Worship Panel and was able to report their activities in full.

Lis Dyson-Jones and Cen Llwyd serve on the Welsh Department and have been well able to communicate between the two bodies.

In November the General Secretary published his Inquirer article "How shall we provide Ministry in the years to come". The provision of ministry to congregations is now scheduled to become the subject of a collaborative investigation between the Denominational Support Commission and the Ministry Commission in 2005.

CONGREGATIONAL CONSULTANCY PANEL

The Congregational Consultancy Panel was formed (as the Small Congregations Consultancy Panel) to oversee the work of the project to help small congregations for which Council voted a Millennium Fund Grant of £43,000. Ten congregations were helped in this way, and the project was generally considered to be a success. The Hucklow Consultancy, which carried out the main work of the project, deserve our thanks and congratulations.

Due to their efficiency and cost control, some of the original funding remained; and the view was taken by the General Secretary and Council that the techniques used in the project should be made available to all congregations, particularly the indepth fact-finding and self-analysis exercise which forms an important part of the process. The remaining funds were therefore used to hold a series of workshops in various parts of England and Wales, which culminated in a training course for facilitators held in Manchester in February 2005. We now have a cadre of ten trained and accredited facilitators up and down the country, who will be available to help any congregation which applies. Which congregation among us is so complacent as to believe that it could not improve, and benefit from a closer look at itself assisted by an outside eye (and ear)?

The Congregational Consultancy Panel as such has now completed its work; its final meeting was held on 21 February 2005. The process will be taken forward by the Denominational Support Commission, which will be responsible for handling applications by congregations to participate in what could be a very valuable tool for congregational growth.

ENGAGEMENT SUPPORT

Two regional engagement seminars for facilitators of engagement groups were held in 2004: one at Cross St. Chapel, Manchester on 12 June, the other at Croydon Church on 03 July. These were attended by both leaders of established groups and people interested in setting up a group.

At the Hucklow Summer School 2004 a weekly morning workshop introduced participants to the principles and process of engagement and was run by members of Engagement Support. The group met three times in 2004 and once in 2005 to evaluate the success of the seminars, to consider how engagement news in individual churches could best be disseminated and to plan future events based on consolidating support for existing facilitators at local and regional levels. Regional support groups have met on a number of occasions and an Engagement Newsletter has been circulated amongst groups.

In early March 2005 a northern training day took place entitled 'Engagement Process as Spiritual Practice'. This will be followed by a similar training day at Croydon.

WORSHIP PANEL

- With a still tight budget, this small panel has had to make changes to its way of working. In particular, worship material has been produced entirely in-house on an expenses only basis and large mailings have been done by panel members themselves, conscious of the wider constraints on resources.
- The panel was grateful to Rev. Keith Gilley for Worship Material to Mark the Centenary of the Induction of Rev. Gertrude von Petzold as England's first Woman Minister (29 September 1904). This significant piece of work, which received a small grant from the Denominational Support Commission, was

- praised by worship leaders who used it in celebratory acts of worship around the country. Prompted by our Unitarian material, the Church Times featured an article about von Petzold.
- Noting that 2005 would mark the bicentenary of the birth of James Martineau, planning began for a pack of Martineau worship material, to be ready for the anniversary, 21 April.
- 4. A number of replies were received in response to an Inquirer article by Richard Lovis and a follow-up by Celia Midgley on innovative worship. It is expected that six of these will appear as a series in The Inquirer in
- 2005 under David Dawson's banner New Patterns in Unitarian Worship. Other articles during the year were written by David and by Joy Croft.
- 6. The panel has been glad of the help of Helen Parsons in tracking down copyright permission for reproduction of the words of Let Us Sing. We are hopeful that the music copyright can also be secured, enabling copies to be produced for those congregations who have requested them.
- 7. As usual, the panel arranged most of the 2004 Annual Meetings worship. Morning services were conducted by Richard Lovis with Anne Ashley, Rev Tom McCready with Rev Alan Kennedy and Simon Ramsey with Jane Williams. Devotions before business sessions were led by John Hewerdine, Mel Prideaux and Mike Jarrett with David Dawson on piano. The Quiet Room was arranged by Christine and David Dawson. All these contributions were much appreciated.
- Along with other panels, the Worship Panel took part in the special presentation by the Denominational Support Commission.

YOUTH PANEL

Mission Statement.

The Youth Panel's aim is to develop and sustain a strong network of young people within our denomination. Ensuring an arena for the presentation of the views and opinions of young people with a view to future membership of the denomination.

We have a commitment to running challenging events for young people that are safe, accessible, enjoyable and run in a professional manner with a Unitarian and Free Christian ethos at their core.

Objectives 2004 and onwards

- i. Appoint a Youth Officer.
- Develop a 3-year plan for the Youth Programme within the denomination.
- iii. Undertake survey of youth within denomination.
- Create National Directory of Youth Leaders/Potential Leaders.
- Ensure that Essex Hall make it a priority that all leaders are adequately trained and Criminal Record Bureau (CRB), checked

The panel continued it's work in line with the above mission statement and objectives. Whilst being disappointed not being able to complete more of the stated objectives the main objective, of appointing a Youth Officer, was completed. This has been a long drawn out process, with the support and collaboration of the DSC, culminating in the appointment of Andrew Green in January of this year. Since the appointment, the Panel and representatives of the DSC and the National Youth Programme, (NYP), met and began the process of completing the other objectives.

National Youth Programme (NYP).

All current NYP events take place at The Nightingale Centre in Great Hucklow, Derbyshire.

Junior Weekend (7-11 year olds)

This very successful weekend, run twice a year, continued unabated with The Nightingale Centre packed to the rafters with excitable children. There was one notable change, however, the retirement of the main leader Heather Foster who has been responsible for the running of the weekend for more years than she cares to remember. The Panel would like to take this opportunity to thank Heather for her commitment and hard work. Hopefully we will see Heather and her children at the weekend as participants in the not too distant future.

Bridging Weekend (11-12 year olds)

Set up as a short-term project, funded by the UMF, Bridging weekend sees it's last outing in March 2005. The weekend was set up to try to address the 'dropping off' of children moving from Junior Weekend to Inter Weekend. This appears to have been a great success with numbers attending Inter Weekend almost doubling.

Inter Weekend (11-14 year olds)

We are happy report an increase in the participants at Inter Weekend, so much so that one of the two weekends run every year was held in the main house(!) instead of the extension; a change that was welcomed by leaders and participants alike.

Senior Weekend (14-17 year olds)

Run three times a year this weekend caters for a teenage age range. Based in the extension rather than the main house this weekend always seem to be a hit with the target age.

YUC Week (14-19 year olds)

Recent years have seen a noticeable drop off in numbers attending the week, run during August. A week dedicated to the development of our young people both emotionally and spiritually, but with having fun being an underlying theme, this has long been a key element within the NYP.

The Future.

Following the joint meeting of Youth Panel, DSC and NYP leaders with Andrew Green, (Youth Officer) a number of initiatives were set in place to address outstanding objectives, or current provision was identified and procedures reviewed.

YUC Week was discussed and a change in format was decided one of two age ranges having different programmes running in tandem.

A survey has been sent out to churches and districts with a view to obtaining information about youth within the denomination.

In line with the fourth objective the Panel is looking for potential leaders for both the NYP and future projects. If anyone is interested please could they contact either Essex Hall or the Panel Chair, by email, with contact details and an indication which age ranges they would like to be involved with.

Andrew Green has undertaken the task of developing a Constitution and set of policy documents for youth provision within the denomination. Also he is looking into the area of leadership training with a view to putting a programme in place.

Sarah Tinker is in place as Child Protection Officer and has the task of completing CRB checks on all leaders.

It is fair to say that the Panel has been reinvigorated and looks forward to working with the DSC and Youth Officer to further the youth movement within the denomination.

And Finally.

The Panel would like to take this opportunity to publicly thank Joan Partington for her hard work and dedication to the GA Youth Programme. Joan once more stepped into the breech, after retiring, when an alternative organiser/leader could not be found for these meetings.

EDUCATION AND TRAINING COMMISSION

Chair: Dawn Buckle Secretary: Ingrid Taykar

Mission Statement: To provide a framework for education and training within the Unitarian movement which enhances the development of people of all ages as both individuals and Unitarians.

The Commission has met twice since the Annual Meetings 2004. It clarified its Terms of Reference and Mission Statement, approved Guidelines for Working Practices and set Objectives to support its Projects and Working Groups. A decision was taken not to promote or provide the Development Skills Training Programme for the time being but to concentrate on other aspects of religious education.

Council agreed a change of personnel in October 2004 when Joan Hill replaced Freda Laverick and Julianne Morgan who stepped down due to ill health and family commitments. It was decided to hold open the second vacancy to recruit appropriate expertise in the future, when needed.

At the Commission's recommendation, Council agreed to transfer responsibility for Child Protection and safety for vulnerable people to Administration Commission. It was felt that the issues involved have wide legal and administrative implications. Police checking, for example, touches on the work of other Commissions. It is more efficient for Sarah Tinker, the National Child Protection Officer, to report to the General Secretary, and therefore involve the Administration Commission.

Chalice Award Scheme

Champions - Joan Hill and Susan Hodgson.

The Champions began collecting a list of leaders of children's religious education in congregations using the Scheme. New Bronze, Silver and Gold certificates were produced to be presented on successful completion of each level.

A new *Green Award* for young children is being trialled currently to be made available during 2005. A draft of this Award is available on the Education and Training Commission stall at the Meetings.

The Champions have made visits to several churches to present awards, promote the scheme and assist with leader training. Links are being made through the new Youth Officer and other Leaders to the National Youth Programme.

Hucklow Summer School Steering Group: Rev Simon John Barlow, Rev Elizabeth Birtles, Jane Blackall (from August 2004), Sheila Jones (until August 2004), Jean Mason, Sarah Tinker (until August 2004), Patricia Walker-Hesson (from August 2004).

The Steering Group planned a very successful Summer School that was fully booked within a few weeks of information going out. Approximately one third of the forty-five adult participants were first timers and there were ten children under seven.

The Dean for the School was Jean Mason, who continues in that capacity this year. The inspirational theme speaker was the Rev Elizabeth Birtles. Workshop leaders from this country and North America provided sessions that were rich and useful, fulfilling the Steering Group's aim to provide personal and leadership development for the participants.

The course this year, at The Nightingale Centre 20-27 August has the theme *Building Beloved Community*. The theme speaker is the Rev Cathal Coutney.

The Steering Group are adopting a policy of giving preference to newcomers and ministerial students.

Joined Up Education

(incorporating the Course in Lay Preaching and the Conduct of Worship - CLPCW).

Working Group: Dawn Buckle, Rev Celia Cartwright, Rev Peter Hewis, Richard Lovis (Distant Member from December 2004), Rev Dr Vernon Marshall (from December 2004), Member from Unitarian Association of Lay Leaders (to be appointed.)

The Working Group is actively seeking a lay member of UALL to join them.

The work of this group includes support for those currently enrolled on the CLPCW and development of a new integrated course on several levels.

CLPCW

The CLPCW continues with the Rev Celia Cartwright as Administrator. There have been a few hiccoughs during this period of change. The Working Group hopes that most of them have been cleared up now. It is still not clear exactly how many students are continuing with the Course as some students fail to inform the Administrator when they are taking a pause from study or have decided to drop out. There will be an opportunity for a student, tutor and Administrator meeting during the Working Group's fringe slot at the Meetings.

After being involved in lay training for around fifty years the Rev Dr Arthur Long stepped down as Tutor. Rev Alex Bradley has agreed to take Rev Long's place. Rev Dr Vernon Marshall and Rev Ernest Baker continue to Tutor the other three modules.

New Course

The proposed new course, which is in draft form, is intended to cater for both lay people wishing to conduct worship, and those wishing to extend their knowledge of Unitarianism. It grows out of courses provided by Districts, and the national 'Taking the Service' course and leads to, for those who want it, Lay Pastor and Ministerial training in the colleges. Further information is available at the Working Group's fringe slot during the Meetings.

Publications:

Co-ordinators: Helen Parsons, Helen Royall.

The Commission are very grateful to Helen Parsons and Helen Royall for taking on the job of bringing to successful publication three useful adult education courses. These courses, by the Rev Jo Ann Lane and the Rev Dr Vernon Marshall were commissioned by the previous Religious Education Department with a grant from the Unitarian Millennium Fund. The courses, Spirituality in Everyday Life, Home and Away, and Unitarian History will be launched during the Meetings.

The Co-ordinators will be working on the publication of further religious education material, both new and revised, during 2005.

Distribution of RE Publications:
The Commission, with permission of Council, transferred the sale of all their publications to the Book Service at Essex Hall, which is administered by the Outreach and Communications Commission. This should lead to a more efficient and effective service for those ordering religious education material.

Religious Education Co-ordinators (RECs) Co-ordinator: Margaret Robinson.

The co-ordinator has been successful in collecting information about religious education in some districts and congregations. Some are very active, such as the London District with its splendid 'Blah' weekend for children. The Commission does not have a clear picture of religious education across the movement. It appears that some Districts that previously appointed a Religious Education Co-ordinator have let the position lapse.

The Commission organised a Fun Day for RECs in Birmingham in September but response was so poor that the event had to be cancelled.

The Commission will be re-visiting this aspect of their brief in the near future to assess what is the best way forward. Maybe a national network is no longer necessary. The Commission would welcome guidance on this from those working in the field.

Conclusion

The Commission has partially fulfilled its identified objectives. It has failed to re-energise the District Religious Education Co-ordinators network. Through its projects and working groups its successes include: the Hucklow Summer School; the publication of three new adult education courses; continuation of the CLPCW; a draft of the new course for lay people; improvements and additions to the Chalice Award Scheme. The Commission itself has successfully transferred Child Protection and associated issues to Administration Commission; and transferred the sale of religious education material to the Book Service.

MINISTRY COMMISSION

The Commission's Mission Statement was agreed as: To plan and take strategic decisions relating to all forms of ministry within the body of the General Assembly; and to ensure the achievement of the highest possible degree of satisfaction for both spiritual leaders and congregations.

Meetings: The Commission met three times during 2004, the first being a residential meeting at the Luther King House, Manchester. This meeting agreed the mission statement and then, after examining the scope of its brief, identified its priorities and formulated the objectives that have determined its subsequent work.

GA Annual Meetings 2004: The work of the Commission was explained at an afternoon meeting, thereby permitting a greater degree of communication and interaction with delegates and members.

The Course for Lay Preaching and the Conduct of Worship (CLPCW): The Revs Peter Hewis and Ann Peart met with members of the Education and Training Commission to co-operate in the revision of the CLPCW. They also collaborated with that Education and Training in its "Joined-up Education" debate.

The Review and Support Panel: Following a considerable demand for its services, the Ministry Commission determined to meet with Review and Support Panel members and consider how this Panel can be strengthened and improved. This meeting has not yet been possible. Dr Jane Williams accepted the Panel's invitation to become a Panel member.

The Forum for the Co-ordination of Training in Ministry: The work of the Forum has been integrated within the scope of this Commission and separate meetings are no longer necessary.

Guidelines: When Guidelines III was produced it was appreciated that this had modified several parts of Guidelines I and II. David Dawson agreed to undertake the considerable task of reviewing all three documents and amalgamate them into one comprehensive booklet. By the close of the year

David had made significant progress. However, the process has highlighted the need to review many aspects of established policies and this will happen in 2005. The Commission also reviewed Appendix B to Guidelines I, the model agreement to appoint a minister, and minor updating edits were agreed.

GA Resolution 5 of 2002: This Resolution concerned the need to develop ministry training to meet the demands of the current social, political and cultural environment within which our congregations exist. A nationwide questionnaire had resulted in a report presented to the GA Annual Meeting 2003. The ensuing cut-backs and re-organisational debates had prevented its deeper consideration by the former Ministry Committee. Iain Brown analysed the raw data. He had completed this task by the end of the year, ready for debate in the 2005 agenda.

Ministry for <u>all</u> congregations: In the last meeting of the year, the General Secretary drew attention to the dramatically increasing number of congregations that no longer had ministry. He proposed that the Ministry Commission should collaborate with the Denominational support commission in a review of this situation, with a view to developing practical ways in which the General Assembly may co-ordinate human and financial resources to benefit our congregations.

GA Roll of Ministers and Lay Pastors: Cathal Courtney, Thomas McCready, Jean McNeile, Simon Ramsay and Christopher Wilson were accepted onto the Roll with probationary status. The Revs Hans le Grand, Gordon Oliver, Kathleen Packer and June Pettitt were granted full status. The Rev John Gill died on 10 September 2004, the Rev Willie Tryfan Huws died on 11 November 2004 and the Rev Charles Magowan Kelly died on 05 November 2004. The Revs Michael Parkinson and Angus McCormick resigned from the Roll. Lay Pastors Dr Beverley Littlepage and Colin Turnage retired. Lay Pastor Ann Edwards resigned from the Roll.

GA Roll of Lay Leaders: Roy Wain was admitted to the Roll. Michael Jarrett, Tom Poole and Roy Wain left the Roll by retirement. Three Lay Leaders will retire from this Roll in 2005 and that will reduce the Roll to one person.

Churches Main Committee: The Commission received copies of circulars issued by this Committee.

Child Protection: Consideration was given for the need to extend the GA's policies to include all who enter training for ministry.

INTERVIEW PANEL

In attendance: Jeffrey Teagle.

The Panel met twice during the year, for two days in January at Oxford and a single day at Unitarian Headquarters. Although still accountable to the Ministry Commission, its role has been slightly widened to enable the Commission to concentrate on policy issues. For instance, the Panel will now deal with all matters concerning individuals.

Maud Robinson and Martin Whitell were accepted into training at Oxford. Gillian Peel and Anthony Howe were admitted for training in Manchester. The colleges and Welsh Department reported upon the progress of students in training. Students Cathal Courtney, Thomas McCready, Jean McNeile, Helen Mills, Simon Ramsay and Chris Wilson attended final year interviews.

The mentor system was monitored and the situation of probationary ministers was monitored. The Ministry Commission and Interview Panel will no longer recommend a ministry student for entry onto the Roll until evidence is to hand that the student has completed the Unitarian college studies and such externally validated courses as were agreed at the outset of training.

OUTREACH & COMMUNICATION COMMISSION

- 1. Meetings: The Commission met twice during the year a residential meeting at Lancashire College, Chorley in November 2003 and a meeting at Essex Hall in May.
- 2. Mission statement, terms of reference and procedures: The Commission agreed the following mission statement: "to promote a clear contemporary Unitarian message via traditional and innovative means and to foster social action

in accordance with liberal values in order to encourage growth and influence society and its culture". The Commission also formulated a 'terms of reference' document and a set of commission criteria to define the approach to be taken to the Commission's work. To encourage submissions for project funding from Panels in particular, the Commission set up a system using special application forms, based on a nine point planning model.

- 3. Panels and Working Groups: The Commission established a small project team, the Information Working Group to carry on the work of the former Information Committee. There are also a number of other Panels and Working Groups which report to the Commission. These are: the Penal Affairs Panel, the Social Responsibility Panel, the Ecumenical Relations Panel, the Interfaith Panel, the Publications Panel and the Hymn Book Working Group.
- Grants: A publicity grant of £300 was awarded to Croydon Unitarian Church for production of a new notice board.

5. Publications/resources

- a) A set of tabletop A2 travelling exhibition boards in full colour was created which are now available for churches to borrow. These boards were launched at the Sea of Faith/Yeast conference in Sheffield in July, their first congregational usage being at Bury St Edmunds Meeting House for the Civic Trust's Heritage Weekend.
- b) The following leaflets were reprinted: Unitarian Views of Jesus, Unitarian Views of Earth and Nature, Unitarianism...The Continuing Story, Unitarian Wedding Ceremonies...A Personalised Approach and Unitarian Views of Human Nature.
- c) The Information Officer worked on issues of Counterpoint and co-ordinated a GA News page for each issue of The Inquirer.
- 6. Advertising and response to enquiries: Adverts were placed in *The Big Issue, Sesame* and *Amnesty* magazines in 2004. Over 120 enquirers received our standard pack of information during the year as a whole the vast majority having sent in a request in response to advertising. In addition, the office handled many enquiries concerning rites of passage arrangements, information about nearest churches, historical research and other requests.
- 7. GA Websites: The number of congregations participating in the GA's free webpage scheme reached the 50 mark during the year. The scheme has operated by means of a team of volunteers

working closely with the Information Officer. Meanwhile, the GA website was updated with news articles reflecting items of interest. Using the search term "Unitarian", the Google search engine ranks the site second behind the UUA out of nearly one and a half million entries.

- 8. Email communications: Subscription to the GA email announcements list was opened up to all and, following a marketing exercise, the number of subscribers increased to over 120. The list provides a means of conveying information swiftly to the movement. More than fifty messages had been sent out on the list by the middle of December 2004.
- 9. Public Media: In March, following a persistent media relations effort, in which GA Outreach and Communication actively drew in support and cooperation from the Public Information Office of the UUA, the BBC launched a website about Unitarianism. This site is accessed from a link at www.bbc.co.uk/religion/religions, and the page lists us on a basis of equality alongside twelve major belief systems including all the main world faiths, plus Atheism and Paganism.

Press campaigns were organised in relation to events linked to the Joseph Priestley and Gertrude von Petzold anniversaries. In the former case, there was widespread coverage in the Yorkshire press; in the latter, there was a substantial article in *The Church Times* and interviews on BBC Radio Leicester and BBC Radio Kent.

A letter was published in *The Times* in response to Ruth Gledhill's article on the future of the movement, and another commenting on the banning of headscarves in French schools. The UCCN email list was increasingly used to notify Unitarians of media mentions and even to disseminate sample press releases which were being adapted successfully for use in the local context.

- 10. GA Annual Meetings: John Hewerdine served as official GA photographer at the Meetings, with James Barry also taking excellent photographs. John and Daphne Roberts once again did sterling work on the GA Bookstall, together with Peter Bixby.
- 11. Training: The Information Officer spoke on public relations strategy at a successful and well-attended UCCN Weekend Conference in February. An interview training session with a media professional was provided for the GA President, Dawn Buckle

A letter offering support for congregations in ecumenical matters has been prepared and was approved by the Panel. Letters have been exchanged with Churches Together In England to keep relations under review. Clarification is being sought from Scotland on the changes that have been made to the constitution of ACTS (the Scottish ecumenical body) which may affect the position of Unitarians. The Questionnaires gathered from congregations, district associations and ministers on ecumenical relations has been analysed by Miles Howarth and the conclusions will be presented at the forthcoming Chester GA meetings.

INTERFAITH PANEL

The Panel has arranged two seminars, one at Essex Hall on Interfaith Relationships and another at Croydon on Fideology, plus a retreat Fintry House on the Parliament of World Religions.

A pamphlet is being prepared for publication of Unitarian Views on Interfaith Relations. A survey / questionnaire has been sent to congregations on local interfaith involvement, and the responses are in the course of evaluation.

Money was given to the Derby Interfaith Centre to provide Unitarian books. For the future a second conference on Fideology has been arranged for 12 November 2005 at Croydon and we are exploring possibilities of a conference at Birmingham.

We thank Matthew Smith for his effective work as our staff liaison during the year.

PENAL AFFAIRS PANEL

- The Panel is now an arm of the Outreach and Communications Commission, OCC. The Panel is responsible to OCC and also submits regular reports to Council.
- 2. The Panel met once formally during the year and four members of the Panel met during the 2004 Annual Meetings. In order to hold costs down members consulted where possible through letters, emails and telephone calls. During this year a day seminar on Volunteering in the Criminal Justice and Penal Systems was approved by the OCC. While the date of the seminar fell in the following financial year, the majority of the planning and liaising with a wide range of bodies, Unitarian and other, took place in the period covered by this report. The Panel was grateful to Cross Street Chapel, Manchester District Association, neighbouring District Associations and Churches' Criminal Justice Forum for their help. A second project, an Issues Paper on sentencing children and young people, was approved for implementation in the course of the following
- Regular mailings from the Panel have been sent to nine Unitarians with interest and experience in penal affairs, three of whom are ministers or retired ministers.
- At the Annual Meetings 2004 the Panel was pleased to support the Women's Group meeting on Women in Prison. At the same meetings the Issues Paper on Volunteering in the Criminal Justice and Penal Systems was distributed.
- A letter was sent to The Inquirer in October 2003 responding to a correspondent who queried whether the issue of prison conditions fell within Unitarian concerns. A letter on sentencing was sent to The Independent in April 2004 but not published.
- 6. The Panel was represented at the four meetings of the Churches' Criminal Justice Forum, CCJF. Two of the four business meetings are followed by Network meetings to which individual members of CCJF are invited. Speakers include government ministers and civil servants, and reports and presentations are given by a number of

- voluntary organisations. In combination these events are of great benefit to the Panel, helping to keep them up to date in a very fastmoving and complex area and allowing feedback via mailings.
- 7. The panel contributes actively to business meetings. Two members of the Panel read the draft of the Catholic Bishops' Conference publication A Place of Redemption, and offered comments and suggestions. The Panel continues to take the lead role for CCJF in interfaith contacts. A member of the Panel was invited by the editor of The Magistrate magazine to write an article on interfaith developments in the area of criminal justice. Advice and help was given to a Muslim researcher, Dr. Basia Spalek, of Birmingham University in connection with research into British Muslims and all aspects of the criminal justice system.

PUBLICATIONS PANEL

The Panel met three times during 2003-4

Whilst we published no new books, members have been very active in gathering material for two forthcoming publications, *Marking the Days* – worship material for special services conceived as a companion volume to *Celebrating Life*, and *Being Together* – a collection of essays celebrating a range of aspects of congregational life. We much appreciate the work of contributors to these volumes.

Other books which have been initiated by members of the Panel are developing albeit rather slowly.

We commissioned a further reprint of the popular *Unitarian? What's That?*

Members have read a number of manuscripts submitted to the Panel and considered one or two ideas suggested to them but have not felt able to proceed with any of these for various reasons – coming from outside the movement, they were not compatible with Unitarianism, or, as academic works, they were insufficiently scholarly, or they would have not been readily marketable, for example.

We have given time to considering how we can improve the marketing of Lindsey Press books and to questing for further books which might reach out to an audience beyond Unitarian circles. We would also like to produce some books aimed at children or teachers, for example introducing Unitarianism to young people.

Again members have been actively engaged between meetings and in regular contact by email.

SOCIAL RESPONSIBILITY PANEL

1 Meetings: The Panel met in October 2003 and in May 2004 at Essex Hall.

2 Mission Statement

"The Unitarian Social Responsibility Panel aims to: PROMOTE social action and concern within the General Assembly of Unitarian and Free Christian Churches. INVOLVE individuals and groups of members throughout the denomination by the processes of education and awareness raising to take up the challenge of direct social action. EQUIP local churches and district associations by whatever means available to become actively involved in matters of social concern. SHARE with other denominations and charities our concern with social issues and our own experience and knowledge in various fields."

3 Denominational Activities

SR Survey: In January 2004, we went 'live' with the SR Survey on present day social responsibility action by both congregations and individual Unitarians. We sent out 138 questionnaires and received 82 returns. Tony Rees produced an interim report, noting that completing the questionnaire had helped to heighten many congregations' awareness about social responsibility activities. A final report will be available in due course, and hopefully give direction to the Social Responsibility function at national level, thus helping to plan future work.

GA Theme 2003-05 "Removing Barriers: Unitarians address disability issues": Three districts - the LDPA, the Eastern Union and the East Cheshire Union - hosted day seminars and

workshops focusing on disability issues such as 'reasonable access' and 'mental health'.

Counterpoint: We produced two issues (Spring & Autumn 2004) of this occasional newspaper with assistance from the Information Officer. We continue to receive positive feedback, especially from first time enquirers and MPs. Thirty-six congregations have requested extra copies for distribution at local level. We have funding for two further issues, during 2005. The quarterly SR Newsletter continued to appear during the year.

Social Responsibility at local level: Many congregations and fellowships were actively involved in social justice action by marking Homelessness Sunday, Peace Vigil weekend; United Nations Day, Racial Justice Sunday, World AIDS Day and One World Week; by supporting Fair Trade Fortnight, Peace Campaigns, Trade Justice Campaigns, and Housing Justice; by raising awareness about Asylum Seekers, Debt on our Doorstep, Disability, World Development, environmental concerns; and by giving monetary support to various local causes.

The SR Co-ordinator was involved in denominational events at all levels, giving talks, facilitating workshops and day seminars, and leading services with a social justice focus.

SR Network: We continued with our efforts to expand the denominational SR network by offering to facilitate workshops and seminars on contemporary social justice issues; by offering our support to existing SR committees and working groups as and when necessary; and by trying to identify those individuals who have time and energy to support our work.

- 4 Ecumenical Activities: We offered our support to and attended meetings of the following ecumenical agencies: Christian Aid; CTBI Church & Society Forum; CTBI Racial Justice Network; Churches World Development Network (CWDN); Church Action on Poverty (CAP); Church Action on Disability (CHAD); Network of Christian Peace Organisations (NCPO); and One World Week (OWW). Our contribution to ecumenism in offering a cost-free venue for meetings at Essex Hall has continued. We have promoted and shared in campaigns organised by CAP, Christian Aid, CAFOD, Housing Justice, and the Trade Justice Movement.
- 5 Secular Activities: The SR Co-ordinator has worked closely with a wide range of non-religious organisations: Amnesty International; Campaign Against the Arms Trade; Campaign for Nuclear Disarmament; Development Education

Association; Friends of the Earth; Greenpeace; United Nations Association UK; UNICEF; WaterAid; World Development Movement; Womenkind Worldwide, and others.

6 Voluntary Work: Rosemary Ruston continues to work one day a week for the Office of Social Responsibility on a voluntary basis, and we would like to thank Rosemary for the valuable contribution she has made.

7 Looking Ahead

GA Motions 2004: offer help where and when needed in formulating GA motions on social justice issues by providing relevant information, background papers and resource packs.

Financial Review

As an expression of support to the Charity's application for a grant from the Landfill Tax Credit Scheme, the General Assembly has agreed

to write off the outstanding loan of £35,000. In order to tie in with the General Assembly the auditors to both parties agreed to show it as a special donation. This inflates the net surplus for the year to £42,848. Excluding that special donation, the net surplus would have been £7,848 against a budgeted surplus of £5,782. Although the trading account shows a deficit of £4,056, other donations of £11,541 (including £6,448 from Friends of Hucklow) and £3,310 from Open Day (has resulted in a positive outcome for the year.

Success in our efforts to attract new business has been offset by a decline in school bookings. This can be directly attributed to the consequences of a more litigious society and the advice to teachers from their Unions not to organise residential trips.

It has been a challenging year but we remain in a strong financial position to move forward with our plans for the development of the Centre.

Development of the Centre

The proposed development which will cost in the order of £250,000 will significantly improve access for disabled and less mobile guests and will provide more en suite twin bedrooms and an upgraded modern Social Hall facility. The work is planned to start in November 2005. The Main House will remain open. During this period, the Youth Programme events which had been scheduled for the self-catering block will be accommodated in the Main House.

New Manager

Lis Shaw left her employment at the Centre at the end of September. The Management Committee wishes to place on record their appreciation for what Liz had achieved in her role as Manager. We are pleased to announce the appointment of Julie Dadson, who commenced her employment on 20 September 2004. We are confident that she has the skills, commitment and enthusiasm to carry forward the success of the Centre.

Pricing Policy

Price increases are always kept at the minimum required tom maintain the financial viability of the Centre. This year it has been considered prudent to increase our charges above the rate of inflation. We have also increased the single room and en suite supplements. Charges to residents continue to be subsidised by our income from Barleycrofts and in addition Unitarians benefit from a further discount. We believe that the Centre still offers extremely good value for money.

We are committed to maintain our support for Unitarian youth activities based at Hucklow. The self-catering accommodation is still charged at only £5 per person per night (winter rate £4). The Centre also offers the 'Send a Child to Hucklow' charity a special rate for their holidays.

Open Day

In June we held our annual Open Day and we are grateful to everyone who contributed to the fun, fellowship and financial success of the day. The amount raised was £3,310.

The Open Day in 2005 will be Saturday 04 June and will be opened by Mike Tomlin.

Income from Open Day, 'Friends of Hucklow' and other donations remain essential to our financial well-being. If distance prevents you being with us on the day maybe your congregation would consider a local fund raising event in aid of the Centre.

1. Objects of the Fund

The objects of the Fund shall be to aid in the maintenance of faithful and efficient Ministers serving congregations affiliated to the General Assembly of Unitarian and Free Christian Churches.

2. The Committee

The Trustees are appointed by the Council of the General Assembly of Unitarian and Free Christian Churches on a triennial basis, to manage the trust as a Departmental Committee of the General Assembly. The Custodian Trustee is the British and Foreign Unitarian Association (Incorporated).

3. Administration of Grants

Application forms for grants are available from the Secretary via the District Associations. The Trustees meet in June or July each year to consider applications for grants for the year commencing the first of October following. The grants are then paid in quarterly instalments.

4. Meetings

The Trustees met once during the year on 15 July. The Officers administering the grants maintained a close liaison amongst themselves throughout the year.

5. Annual Accounts

The Accounts for the year ended 30th September 2004, showed an operating surplus of £2,955 (2003: £954 deficit). After a net investment gain from disposals of £3,316 (2003: £21,981) and a year end market revaluation gain of £13,394 (2003: £2,559), there was an overall surplus of £18,848 (2003: £21,946) for the year.

Investments

Mellon Fund Managers Ltd, previously known as Newton Investment Management Ltd, 71 Queen Victoria Street, London EC4V 4DR, continued as Investment Managers. The investments are held in the name of the Custodian Company of the Bank of New York, 1 Canada Square, 'London E14 5AL, on behalf of the Trustees, and may be held outside the 'United Kingdom. The investment policy is to maximise the total return from a portfolio managed to produce a balance between income and growth. It may be necessary from time to time, to supplement income by withdrawals from Capital growth. The investments were valued as at 30th September 2004 by Mellon Fund Managers.

7. Grants

Applications for grant-aid towards the payment of stipends were received for the support of 23 Ministries, of which 4 were new applications. Of these 23 applications, 1 was refused. Of the 22 awards made, 3 ceased part way through the year due to the Ministers moving elsewhere or retiring.

It has always been a condition of the payment of the grants, that the recipient should have paid the General Assembly Quota in respect both of the previous year and of the year during which the Grant is paid. Following the decision of the General Assembly Council that each Congregation should pay its Quota by no later than 31st December each year, it has been further decided that the Grants shall be withheld from any Congregation whose Quota is still unpaid by the following 31st March, and not reinstated until it had paid its share of the Quota.

Two meetings were held during the year.

- UNITARIAN WEB SITE: Jamie Nemeth is working on a project creating a Welsh and English language website. Links should be included to the GA and Congregational websites in existence already. It would also include articles from 'Yr Ymofynnydd' and from the South East Wales District News, together with a Calendar of Events.
- PENRHIW GATHERING: Over 80 people attended the Rally at our chapel at St Fagans with the chapel comfortably full. Good to have a number of visitors including a small group of young people from France. There was a wonderful atmosphere with exceptional

- singing. Gerallt Nash, keeper of buildings, gave a talk on the work done at the Museum.
- 3. MINISTRY: A brief discussion on the Future of Ministry took place and it was reported that both the South East Wales and the South Wales Districts were holding meetings to discuss this. This was the first phase and each congregation would have the opportunity of discussing the matter after a report back had been completed. Wyn Thomas was Student Pastor at the Llandysul Group of churches for a period of six months. Rev Alun Wyn Dafis had resigned his Ministry. Wyn Thomas had visited Manchester College Oxford and was due to go to Manchester (UCM) in March. He will also spend a short period of time with four different ministers in London, Manchester and Lancashire. He had enrolled for the first part of an M.A. Course at Lampeter.

Trustees' Responsibilities in Relation To The Financial Statements

- · Select suitable accounting policies and then apply them consistently;
- Make judgements and estimates that are reasonable and prudent;
- State whether applicable accounting standards and statements of recommended practice have been followed subject to any departures disclosed and explained in the financial statements; and
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 1993. They are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

INDEPENDENT AUDITORS' REPORT TO THE TRUSTEES OF THE GENERAL ASSEMBLY OF UNITARIAN AND FREE CHRISTIAN CHURCHES

We have audited the financial statements of the General Assembly of Unitarian and Free Christian Churches for the year ended 30 September 2004, which comprise the Statement of Financial Activities, the Balance Sheet and related notes. These financial statements have been prepared under the historical cost convention as modified by the revaluation of certain fixed assets and the accounting policies set out therein.

This report is made solely to the General Assembly of Unitarian and Free Christian Churches members, as a body. Our audit has been undertaken so that we might state to the charity's members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the charity and the charity's members as a body, for our audit work, for this report, or for the opinions we have formed.

Respective Responsibilities of Trustees and Auditors

The trustees' responsibilities for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards are set out in the statement of Trustees' Responsibilities.

We have been appointed as auditors under section 43 of the Charities Act 1993 and report in accordance with regulations made under section 44 of that Act. Our responsibility is to audit the financial statements in accordance with relevant legal and regulatory requirements and United Kingdom Auditing Standards.

We report to you our opinion as to whether the financial statements give a true and fair view and are properly prepared in accordance with the Charities Act 1993. We also report to you if, in our opinion, the Trustees Annual Report is not consistent with the financial statements, if the charity has not kept proper accounting records, or if we have not received all the information and explanations we require for our audit.

We read other information contained in the Trustees' Annual Report, and consider whether it is consistent with the audited financial statements. We consider the implications for out report if we become aware of any apparent misstatements or material inconsistencies with the financial statements. Our responsibilities do not extend to any other information.

Basis of Audit Opinion

We conducted our audit in accordance with United Kingdom Auditing Standards issued by the Auditing Practices Board. An audit includes examination on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgements made by the trustees in the preparation of the financial statements, and of whether the accounting policies are appropriate to the General Assembly's circumstances, consistently applied and adequately disclosed.

We planned and performed our audit so as to obtain all the information and explanations which we considered necessary in order to provide us with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement, whether caused by fraud or other irregularity or error. In forming out opinion we also evaluated the overall adequacy of the presentation of the information in the financial statements.

Opinion

In our opinion the financial statements give a true and fair view of the state of affairs of the General Assembly of Unitarian and Free Christian Churches as at 30 September 2004 and of its incoming resources and application of resources in the year then ended and have been properly prepared in accordance with the Charities Act 1993.

The General Assembly of Unitarian and Free Christian Churches

Notes to the Accounts for the Year Ended 30 September 2004

1) Accounting Policies

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of investments at market value and in accordance with applicable accounting standards. In preparing the financial statements the General Assembly follows best practice as set out in the SORP "Accounting and Reporting by Charities' issued in October 2000 and the Charities Act 1993. The principal accounting policies adopted in the preparation of the financial statements are as follows:

a. Donations, legacies and gifts

Donations, legacies and gifts are included in the year in which they are receivable, which is when the General Assembly becomes entitled to the resource.

b. Investment income

Income from investments is accounted for in the period in which the General Assembly becomes entitled to the receipt.

c. Resources expended

All expenditure is included on an accruals basis. A detailed analysis of expenditure and allocation between funds is detailed in notes 8 to 11 to the financial statements. Grant expenditure is detailed in note 2 to the financial statements.

d. Staff salary costs

Approximately 50% of full time equivalent staff hours are spent on programme work. Accordingly total salary costs have been split equally between programme support costs and management and administration costs.

e. Funds accounting

Funds held by the General Assembly are :

Unrestricted general funds – these are funds which can be used in accordance with the charitable objects at the discretion of the trustees.

Designated funds – these are funds set aside by the Trustees out of unrestricted general funds for specific future purposes or projects.

Restricted funds – these funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor, or when funds are raised for particular restricted purposes.

Endowment funds – permanent and expendable endowment funds are the result of gifts to the charity that are to be invested and the income thereof used for the purposes of the charity either as restricted or unrestricted funds depending on the wishes of the donor.

f. Fixed asset investments

Investments are included at closing mid-market value at the Balance Sheet date. Any gain or loss on revaluation is taken to the Statement of Financial Activities.

g. Tangible fixed assets and depreciation

Freehold land and property held jointly are not depreciated. The cost of equipment is written-off by equal annual instalments over their expected useful lives as follows:

Furniture 5 years
Computer Equipment 3 years

h. Stock

Stocks are valued at the lower of cost and net realisable value.

i. Pensions

The General Assembly operates a defined contribution scheme available to all eligible employees. The assets of the scheme are held separately from those of the charity in independently administered funds. Pension costs charged in the Statement of Financial Activities represent the contributions payable by the General Assembly in the year.



- The Land and Buildings comprised in the Charities called The Unitarian Convalescent and Holiday Centre are vested in the British and Foreign Unitarian Association (Incorporated) as Custodian Trustee. The Convalescent and Holiday Centre was valued at 30th September 1999 for insurance purposes at £1,265,000 and the Barleycroft Building was valued at 30th September 1999 for insurance purposes at £400,000. For the purpose of capitalising the Land and Buildings the value of the Net Building Improvements amounting to £253,353 at 30th September 1999 has been deducted from the valuation to arrive at a net valuation of the Land and Buildings of £1,411,647.
- 2 Income received from Appeal funds is not reflected within the Income and Expenditure Account but taken directly to the Fund to which it relates.
 When Appeal Funds are closed they are transferred to the Capital Account.

3 Accounting Policy

Building improvement works are capitalised.

4 Depreciation Policy

Maximum forty years for building improvements and twenty five years for furniture and equipment.

Freehold Property is not depreciated as, in the opinion of the Committee, the property is not worth less than its book value and, therefore, any depreciation would be immaterial.

5 Investments

The investments consist of 25 Charifund Accumulation Units and 13.16 COIF Charities Investment Fund Units.

Report of the Trustees

1. Objects of the Fund

The objects of the Fund shall be to aid in the maintenance of faithful and efficient Ministers serving congregations affiliated to the General Assembly of Unitarian and Free Christian Churches.

2. The Committee

The Trustees are appointed by the Council of the General Assembly of Unitarian and Free Christian Churches on a triennial basis, to manage the trust as a Departmental Committee of the General Assembly. The Custodian Trustee is the British & Foreign Unitarian Association (Incorporated).

3. Administration of Grants

Application forms for grants are available from the Secretary via the District Associations. The Trustees meet in June or July each year to consider applications for grants for the year commencing the first of October following. The grants are then paid in quarterly instalments.

4. Meetings

The Trustees met once during the year on 15th July. The Officers administering the grants maintained a close liaison amongst themselves throughout the year.

5. Annual Accounts

The Accounts for the year ended 30th September, 2004, showed an operating surplus of £2,955 (2003:£954 deficit). After a net investment gain from disposals of £3,316 (2003:£21,981) and a year end market revaluation gain of £13,394 (2003:£2,559), there was an overall surplus of £18,848 (2003:£21.946) for the year.

6. Investments

Mellon Fund Managers Ltd, previously known as Newton Investment Management Ltd, 71 Queen Victoria Street, London 'EC4V 4DR, continued as Investment Managers. The investments are held in 'the name of the Custodian Company of the Bank of New York,1 Canada Square, 'London E14 5AL, on behalf of the Trustees, and may be held outside the 'United Kingdom. The investment policy is to maximise the total return from'a portfolio managed to produce a balance between income and growth. It may be necessary from time to time, to supplement income by withdrawals from Capital growth.

The investments were valued as at 30th September 2004 by Mellon Fund Managers.

Applications for grant-aid towards the payment of stipends were received for the support of 23 Ministries, of which 4 were new applications. Of these 23 applications, 1 was refused. Of the 22 awards made, 3 ceased part way through the year due to the Ministers moving elsewhere or retiring.

It has always been a condition of the payment of the grants, that the recipient should have paid the General Assembly Quota in respect both of the previous year and of the year during which the Grant is paid. Following the decision of the General Assembly Council that each Congregation should pay its Quota by no later than 31st December each year, it has been further decided that the Grants shall be withheld from any Congregation whose Quota is still unpaid by the following 31st March, and not reinstated until it had paid its share of the Quota.
